

## **ZOOM Instructions for Accessing Municipal Road and Bridge Revolving Fund Project Priority List Hearing**

The public can join this Zoom meeting electronically by computer, smartphone or tablet using the instructions below. You may also join by telephone only.

### **Accessing the Zoom Meeting via Computer, Tablet or Smartphone:**
