ALL CLAIMS SHOULD INCLUDE:

- Your name, address, and telephone number
- The name and address of agency, institution, or department you believe discriminated against you.
- How, why, and when you believe you were discriminated against. Include as much specific, detailed information as possible about the alleged acts of discrimination, and any other relevant information.
- The names of any persons, if known, whom RIDOT could contact for clarity of your allegations.

NONDISCRIMINATION AUTHORITIES

In addition to Title VI of the Civil Rights Act of 1964, several statues, laws, regulations and Executive Orders govern RI-DOT's Title VI Program, including:

- Federal-Aid Highway Act of 1973
- Section 504 of the Rehabilitation Act of 1973
- Americans with Disabilities Act of 1990
- Age Discrimination Act of 1975
- Uniform Relocation Act of 1970
- Executive Order 12898, Federal Action to Address Environmental Justice in Minority Populations and Low-Income Populations
- Executive Order 13166, Improving Access to services for Person with Limited English Proficiency.

What is Title VI?

Title VI of the U.S. Civil Rights Act of 1964 is the federal law prohibiting discrimination on the basis of race, color, or national origin in any federally assisted program or activity.

"No person in the United States shall, on the grounds of race, color, or national origin, be excluded from participation in, be denied benefits of, or be subjected to discrimination under any program or activity receiving Federal Financial assistance."

THE RHODE ISLAND DEPARTMENT OF TRANSPORTATION (RIDOT), AS A RECIPIENT OF FEDERAL FUNDS, IS COMMITTED TO COMPLYING FULLY WITH TITLE VI AND RELATED NONDISCRIMINATION GUIDELINES. TO THAT END, RIDOT DOES NOT— ON THE BASIS OF RACE, COLOR, SEX, NATIONAL ORIGIN, AGE, DISABILITY, OR INCOME STATUS-EITHER DIRECTLY OR BY CONTRACT:

- DENY ANY SERVICE, AID, OR OTHER BENEFITS
- PROVIDE A SERVICE, AID, OR BENEFIT THAT IS DIFFERENT THAN WHAT IS PROVIDED TO OTHERS; OR
- SEGREGATE INDIVIDUALS OR TREAT INDIVIDUALS SEPARATELY IN ANY MATTER RELATED TO ANY SERVICE, AID, OR OTHER BENEFITS.

RIDOT IS ALSO COMMITTED TO PROVIDING MEANINGFUL ACCESS TO PERSONS OF LIMITED ENGLISH -SPEAKING ABILITY.

IMPLEMENTING TITLE VI

RIDOT's Office of Civil Rights provides guidance and support to RIDOT employees to ensure meaningful implementation of the Title VI principles in the department's daily operations. The office also oversees the department's sub-recipients of federal funds to ensure their compliance with Title VI.
